**THE APPLICATION**

**West Coast Touring Motorcycle Club Incorporated** applies for an on-site Special Licence in respect of premises situated at Back Creek Road, Woodstock known as the "**Woodstock Domain.**"

The licence is to host the annual Woodstock rally. It is estimated that up to 400 people will attend the events.

Substantive food and low alcohol and non-alcoholic beverages will be available at all times from various outlets and a certificated manager will oversee the sale, supply and consumption of alcohol.

The days and hours sought are:

**Friday 26 January 2024 12.00 noon to 2.00am the following day,**  
**Saturday 27 January 2024 12.00 noon to 12.00 midnight**

## **THE REASONS FOR THE DECISION**

The Inspector has provided a report on the application and believes the application meets the criteria for issue.

Two experienced certificated managers will be overseeing the sale, supply and consumption of alcohol.

Neither the reports of the Police nor that of the Medical Officer of Health raises any matters in opposition.

Most attendees will be camping on site and security will be engaged for gate control. Intoxication levels must be closely monitored.

Neighbours have been advised of the event, but noise must still be carefully monitored to ensure no noise nuisance is created.

The whole of the venue will be a Restricted Area with no BYO alcohol allowed. .

Overall, I am satisfied as to the matters to which we must have regard as set out in s.142 of the Act.

## **DECISION**

The District Licensing Committee, pursuant to the Sale and Supply of Alcohol Act 2012 **grants** the application by **West Coast Touring Motorcycle Club Incorporated** for an on-site Special Licence in respect of premises situated at Back Creek Road, Woodstock known as the “**Woodstock Domain**” subject to conditions.


### **Conditions:**

The licence is subject to the following conditions:

1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours:  
  
    **Friday 26 January 2024 12.00 noon to 2.00am the following day,**  
    **Saturday 27 January 2024 12.00 noon to 12.00 midnight;**
  2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
  3. A certificated manager must be on duty at all times when the premises are open for the sale and supply of alcohol;

4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard.
5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic beverages.
6. The Licensee must display signage as follows:
  - a) At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - b) A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
  - c) A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
7. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.
8. **No BYO alcohol is permitted to be brought into the venue.**
9. **The whole of the venue is designated as a Restricted Area.**
10. **The Alcohol Management Plan provided shall be followed at all times.**
