# PRESENTATIONS

Melanie Anderson, Chief Executive Officer, Destination Westland Limited provided a verbal update regarding trail maintenance that has taken place over the past 3 months including:

- Clearing culverts & a lot of leaf blowing
- Kumara to Larrakins upgrade of hill section with resurfacing.
- Storm damage repairs have been done out Milltown way.
- Safety enhancements have been installed at Milltown (Switch back safety rails)
- A shelter had been vandalised on the trail.
- Work has been done on erecting and taking down signage regarding the stop bank work.
- Work has been done in the Ross section of the trail clearing vegetation and culverts.
- Clearing windfall damage which is normal for this time of the year.

M. Anderson gave a general reminder to the Sub-Committee that reporting of any maintenance issues on the trail need to go through the proper channels – not directed to the maintenance staff. Maintenance issues are to be reported through Erle Bencich, Operations Manager, Westland District Council in the first instance.

# 7. PŪRONGO KAIMAHI REPORTS

# Capital Projects Update

Erle Bencich, Operations Manager, District Assets provided a general overview of what has been taking place on the trail of recent months including:

- Water Race section has been completed.
- Larrakins Road Project is in final design, pending some items back from Heritage NZ.
- Totara Bridge review documentation will be provided next week from WSP (please put in full all the abbreviations in the minutes) regarding future design for the bridge, safety, and stability.
- A section of trail at the Dillmans Dam has been completed, near the spillway.
- Mahinapua Walkway funding obtained for design, and pending costings to come back from contractors which will define what can be done on the boardwalks.
- Work on the viewing platform on the Mahinapua Walkway section will be started the week commencing 21 August 2023.
- The remedial work on the section of trail on the Kaniere Tram is progressing.

E. Bencich advised he had received some complaints about issues with track maintenance at Kaniere Water Race and Mahinapua. T. Thrupp requested the list of complaints be sent to him of the problematic areas to review.

The Chair commended the work that the Department of Conservation do on the track and their collegial working relationship with the Westland District Council staff to upgrade and develop the track.

### Herenga ā Nuku Aotearoa – The Outdoor Access Commission

Inger Perkins, Regional Field Advisor, The Outdoor Access Commission spoke to this item and provided the following update:

### • Actions from last meeting

A workshop has now been scheduled for 21 September 2023 and I. Perkins advised she is keen to gather resources for the group to read prior to the workshop in order to be prepared and enable those attending to be fully informed, which will aid discussion on the day.

The CE advised that the Workshop would generate a lot of discussion and advised that they are trying to get someone from Sports Canterbury who has practical experience and aspirational knowledge to help facilitate at the Workshop. The workshop is to facilitate open discussion, and to start piecing together a programme of work moving forward.

# Racecourse Development – Hub Potential

Potential as active cycling / walking hub.

The CE advised that there is a report going to Council on 24 August 2023 which will outline the process of being able to contribute thoughts and ideas towards the Racecourse Development.

# • National Walking and Cycling Plans

New plans in the pipeline from Waka Kotahi. Herenga a Nuku Submission made points that could inform the sub-committee at the workshop next month.

#### Locked gate across unformed legal road

There is still on-going concern regarding access and the locked gate at Ruatapu. I. Perkins is hoping to have an update on Monday from Destination Westland Limited regarding this issue and commented that she was disappointed that it has taken this long, well over seven years to resolve.

Cr Neale had asked M. Anderson earlier in the meeting about progress to resolve the locked gate on legal road in Ruatapu. M. Anderson had declined to respond explaining that her presence at the meeting was in relation to maintenance on the West Coat Wilderness Trail only.

Moved Cr O'Connor, seconded Cr Neale and <u>Resolved</u> that the update report from Inger Perkins, Regional Field Advisor, The Outdoor Access Commission be received.

# Westland Mountain Bike Club

Liam Anderson, Club President, Westland Mountain Bike Club, provided a verbal update on the following items:

- The planning of a new entry trail into the forest has progressed, and the Club has identified a local, commercial, trail builder who is happy to dig the trail for the club. Approval has been obtained from Ngāi Tahu Forestry to use the digger to build the trail.
- Westland Mountain Bike Club are working with Sign-Link Graphics to develop signage into the forest as well as key points around the trail to help with navigation.
- Next year a celebration is planned for the 150 years of Connection between the West Coast and the surrounding areas. The Westland Mountain Bike Club are looking at ideas and ways to show case this celebration with a possible Cycle Festival.

# Subject: West Coast Wilderness Trail Trust Update

This month is the 10 year anniversary of the trail officially opening. The vision and what has been achieved is a credit to everyone involved. It is delivering as a recreation asset to the local communities and has grown to become one of the leading trails amongst the Nga Haerenga Great Rides attracting around 16,000 visitors each year. The Trust is proposing to celebrate this with a function in December in conjunction with the opening of the Mahinapua Lookout. The dates and nature of the event are yet to be finalised.

Below is an update on all the key work undertaken in the last three months.

**Accessible Ride Guide** – This is nearing completion and is likely to be launched at the anniversary event.

Website Upgrade – A new website has been created and is about to go live.

**Guide Book** – The content has been prepared. The design work is about to be undertaken. We are aiming to have this completed in early December.

Wards Road Panel – This has been completed and is about to be printed and installed.

**West Coast Wilderness Trail Trust Strategy Plan** – The Trust has reviewed the strategic plan. Much of the content remains the same, however the projects within the Westland District Council's LTP for the trail and those of the Trust have been added to present a fuller picture of all the work being undertaken. Trustees are also keen to see more local media on the trail and to try and gain more major sponsorship for the Trust and the projects planned.

**10 Year Celebration** – As mentioned above, some initial planning has been undertaken to celebrate the 10 year milestone, potentially on the 16<sup>th</sup> December.

**GDC Section** – I have met with Aaron Haymes about the repairs to their section. When the new transport planner is appointed we aim to meet regularly and work together on an enhancement plan for the Grey section of the trail. The Council is also working on some changes to the trail in the wharf area to accommodate new business at the port. This is likely to require a small diversion.

**NZCT Survey** – As we move into the season, we are now picking up the collection of email addresses for sending the link to the survey. Over Labour Weekend I spoke with a large number of riders and collected around 70 addresses. The trail has remained as the second largest contributor of surveys amongst the trail network. This is surprising as some trails have many more riders than us. Last year we engaged a student to help with the collection over the peak holiday period. We are repeating this again this summer.

**Donation Flyers** – We have had a further 7,000 flyers printed. These are kept in the shelters, given to some operators to have in rooms and handed out with the survey work. This aims to target the independent riders. A number of the companies with riders on the trail either contribute per rider or encourage their riders to make a donation.

NZCT Annual Forum – I attended this at the start of October. It brings all Trail Managers together with the NZCT Board, MBIE, DOC, Waka Kotahi and others. This was a good networking event. The topics discussed included unpacking the Government's role in the Great Rides and MBIE funding reductions; exploring operating models for the Great Rides on public conservation land; the work being undertaken nationally by a working group led by Recreation Aotearoa in improving the accessibility of trails; an update from Waka Kotahi; what's happening with trails and cycling in Australia; the Great Rides Persona market research insights; restoring nature on trails; waste elimination; the power of purposeful consultation with Iwi; NZCT's marketing update and the positioning of the trails in Destination Management Planning. All up, there were a lot of interesting topics and discussion and a recognition of how far the Great Ride Network has come.

#### Communications -

Media - Over recent weeks I have released several media articles on a range of topics. These have included voluntary projects on the trail, separate articles on dogs and motor bikes on the trail, the Mahinapua Lookout and work on that section of the trail. I have also provided an article to The Herald on 10 years of development of the trail.

Facebook – We continue to upload regular posts on trail alerts and activities. I have also started short videos and aim to record these with many of our OPPs on them and their products.

E- Newsletter – Another e-Newsletter has gone out and has been well received.

# Cycling and Walking Sub-Committee Report: November 2023

- Grey District Council are currently working through the Long-Term Plan 2024-34 preliminary stages. Included in the planning for recreational spaces.
- We are working with Sport Canterbury to develop a Play, Active Recreation & Sport strategy to guide future decision making in the District with a diverse working party feeding into this.
- We are still seeing events happening on the Wilderness Trail. The Greymouth Harriers 2/4-person relay held most recently from Kumara to Greymouth.
- Fantastic Flow track developed at Blackball School with the concept from the children and design by the children with a huge community input to developing the track. It was officially opened this month and is worth visiting to see what can be achieved by one of the regions smallest schools.
- From Sport Canterbury, we're pleased to have supported the facilitation of the recent Cycling & Walking Workshop held at Westland District Council.

# Update from Inger Perkins, November 2023

Herenga ā Nuku Aotearoa, the Outdoor Access Commission

## 1. Racecourse Development - hub potential

At the recent presentation to stakeholders, it was very encouraging to hear about and see illustrated the concept of the racecourse as a hub for active transport and recreation, including walking, cycling and horse riding.

### 2. Workshop

Many thanks to those who arranged the workshop last month ...

Workshop summary included areas the committee could consider and support through long term plans etc. Safer school access is a place to start, and then extend to supporting a culture shift that gives priority to pedestrians at crossings and gives equality of access opportunities for vehicles, pedestrians and cyclists generally rather than putting vehicles first. An excellent concept that was raised in the workshop is to consider safety for those aged 8 and aged 80. If they are safe, it's likely that all users will be safe.

What do we do next?

- Review and apply International Charter for Walking?
- Use Waka Kotahi's Walking Action Planning guidance?
- Assess streets using Healthy Streets template and find the 'low hanging fruit'?

As Simon Bastion advised at the last meeting, the workshop aims to start piecing together a programme of work and at the workshop advised that there are opportunities to contribute to LTP, 10 year plan, transport budget, and racecourse plan.

Perhaps we could agree on how that will work in practice.

# 3. National Walking and Cycling Plans - Waka Kotahi

I noted previously that Waka Kotahi have been developing a National Walking Plan and a National Cycling Plan. They will be briefing the incoming Transport Minister on those plans to get the new Minister's direction. For now, their focus in this area of work is delivering actions on their interim cycling plan.

I understand that Waka Kotahi support <u>Low Cost Low Risk projects</u> with co-funding through the National Land Transport Programme. Qualifying activities include projects under the Road to Zero campaign and walking and cycling improvements. It may be that the Pine Tree Road link for walking and cycling connectivity could fit this programme, with half the cost to be met by the Council.

#### 4. Pine Tree Road

Could we put a date on this action – to report back on how and when this connection between communities and other bike trails could be achieved? Perhaps this committee could support the project through the Long Term or Annual Plan.
