The comment that we keep hearing from the same few voices over and over again is a bit rich.

Or indeed to be accused of condescension by someone comparing us to their own ten year old.

But here'?s a childhood analogy. This whole thing reminds me a bit of your mate in high school who tells you he has a new girlfriend, but that you wouldn'?t have met her because she lives in Canada.

We were promised a popular revolt from within the organisation, and it didn'?t happen. Now we'?re told that they'?re just the silent majority, the most political clutching at straws.

What I'?ve heard - both at our zone meeting and earlier this week - is broad agreement that;

- a. Internal communication around the Heads of Agreement could have been handled better (likewise communication to and from the Steering Group);
- b. A commitment from LGNZ to do better in this regard with future discussions (that are a only enabled by the HoA framework);
- c. A shared set of concerns about the government'?s water reform programme (that have been expressed by LGNZ as a collective and many councils individually);
- d. That trying to tear up or relitigate the Heads of Agreement at this point would be an act of bad faith, and seriously impede our ability to influence subsequent legislative reform (of which there is plenty).

There didn'?t appear to be any groundswell to push LGNZ to focus its advocacy solely on opposition to water reform at the expense of everything else we'?re trying to achieve.

And given that there isn'?t a single view of the membership, and many members have spoken in favour of the general direction water reform is heading, why would anyone expect that to be the case?

Nobody is asking you to back down, or do anything differently in your district. The HoA is explicit in allowing for all members (individually) to respond as they see fit for them.

Agree with all the other comments that have been made around unity, asides from where they'?re intended as a synonym for acquiescence.



Thank you for organising the zoom meeting this morning.

It confirmed the wide range of views of different Councils around NZ. It is unrealistic to expect all Councils to agree. I note that we only heard the views of approx. 26 Councils out of 67 Councils this morning.

Our Council is not saying what is right for other Councils. We don'?t expect other Councils to say what is right for our Council, and the significant number of Councils with a similar view to ours.

MDC is supportive of the suggestions from Mayor Dan Gordon. We expect LGNZ to represent the views of the significant number of Councils that have the same view as MDC. We also understand that LGNZ needs to represent the views of other Councils as well.

Our Council and community totally oppose the proposed 3 waters reform in their present format. We consider that it would be difficult, if not impossible, for LGNZ to represent our views when LGNZ had agreed to not actively oppose the reforms. Our

group of Councils requires representation.

We look forward to hearing back from LGNZ as to a suggested way forward and whether or not LGNZ will be representing Councils with the same views as ours.
