# The Application

The Craypot Jackson Bay Limited applies for the renewal of the ON Licence in respect of premises situated at The Esplanade, Jackson Bay known as "The Craypot".

The business is that of a Class 3 restaurant/cafe at the remote fishing port at Jackson Bay. The converted Food Truck and surrounding tables have been in operation for four years.

The current days and hours are **Monday to Sunday 11.00am to 9.00pm**. **No changes are sought**.

These hours are within the default national maximum trading hours for ON licensed premises.

The application was publicly notified on the council website from the 16<sup>th</sup> of February 2023. No objections were received from members of the public.

#### Reasons for the Decision

Neither the Police nor the Medical Officer of Health has raised any matters in opposition. Both make mention of a potential issue with one of the certificated managers at The Craypot.

That is a matter for the future if it does eventuate. I am sure the agencies will bring that matter to the attention of the Committee in due course, should it be warranted.

The inspector reports that the amenity and good order of the area has not been reduced by more than a minor extent.

I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.

I deal with the application on the papers.

### **DECISION**

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** an application by **The Craypot Jackson Bay Limited** for the renewal of the ON Licence in respect of premises situated at The Esplanade, Jackson Bay known as "**The Craypot**" subject to conditions.

We refresh the licence conditions to reflect best practice.

## Conditions:

The ON licence is subject to the conditions listed below:

1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:

Monday to Sunday 11.00am to 9.00pm;

- 2. No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day to any person other than a person who is on the premises to dine;
- 3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 4. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 5. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with

the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted;

- 6. A properly appointed certificated, or Acting or Temporary, manager must be on duty at all times when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises;
- 7. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises;
- 8. The Licensee must display:
  - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol:
  - c. A copy of the licence attached to the premises so as to be easily read by persons attending the premises;

The renewal will be for three years from the expiry of the current licence and a replacement licence is to be issued.
