ADOPTION OF FREEDOM CAMPING BYLAW

1 SUMMARY

- 1.1 The purpose of this report is to seek Council adoption of the Freedom Camping Bylaw, following consideration of submissions received under the Special Consultative Procedure as per Section 83 of the Local Government Act 2002.
- 1.2 This issue arises from concern that, under the Freedom Camping Act 2011, the Council has no regulatory powers in relation to freedom camping without a bylaw. The Council's previous Freedom Camping Bylaw 2012 was revoked in 2013.
- 1.3 Council seeks to meet its obligations under the Local Government Act 2002 and the achievement of the District Vision adopted by Council as part of the Long Term Plan 2018-28. These are stated on Page 2 of this agenda.
- 1.4 This report concludes by recommending that Council adopt the attached bylaw.

2 BACKGROUND

2.1 The Freedom Camping Act 2011 ('the Act') defines 'freedom camp' as follows:

"to camp (other than at a camping ground) within 200 m of a motor vehicle accessible area or the mean low-water springs line of any sea or harbour, or on or within 200 m of a formed road or a Great Walks Track, using 1 or more of the following:

- (a) a tent or other temporary structure;
- (b) a caravan;
- (c) a car, campervan, housetruck, or other motor vehicle."

- 2.2 The Act states that freedom camping "does not include the following activities:
 - (a) temporary and short-term parking of a motor vehicle;
 - (b) recreational activities commonly known as day-trip excursions;
 - (c) resting or sleeping at the roadside in a caravan or motor vehicle to avoid driver fatigue."
- 2.3 The Act permits freedom camping in any local authority area (i.e. land controlled by the local Council rather than private entities or central government), unless it is restricted or prohibited by a local bylaw or any other enactment.
- 2.4 According to Section 11 (2) of the Act, a local authority can only make a bylaw restricting or prohibiting freedom camping "if it is satisfied that:
 - (a) the bylaw is necessary for 1 or more of the following purposes:
 - (i) to protect the area:
 - (ii) to protect the health and safety of people who may visit the area:
 - (iii) to protect access to the area; and
 - **(b)** the bylaw is the most appropriate and proportionate way of addressing the perceived problem in relation to that area; and
 - (c) the bylaw is not inconsistent with the New Zealand Bill of Rights Act 1990."
- 2.5 The above requirements mean that Council cannot simply ban or restrict freedom camping across its entire district or parts of its district, without justification. Competition with existing accommodation providers is not a permissible reason.
- 2.6 Council's previous Freedom Camping Bylaw 2012, enacted in November 2012, prohibited freedom camping from all Council public reserves, as well as all public land and roads within 18 townships / settlements and 1km from their boundaries. Enforcement powers were given to several members of the community in South Westland.
- 2.7 The New Zealand Motor Caravan Association (NZMCA) brought a claim against the Bylaw to the High Court in January 2013, on the grounds that the prohibitions were too far-reaching and unjustified. In September 2013 Council repealed the Bylaw, retaining a Freedom Camping Policy as an educational (but unenforceable) document.
- 2.8 In the past five years, there have been some complaints by the public that freedom camping is occurring in inappropriate locations within Westland District. Some of these locations are under the control of the New Zealand Transport Agency (e.g. state highways) or Department of Conservation, while others are under Council control and could be prohibited or restricted with an

appropriate bylaw. Other complaints have been received that freedom campers, primarily those using non-self-contained vehicles, are disposing of their waste inappropriately.

2.9 At its 11 October 2018 meeting, the Council approved a Statement of Proposal for a Special Consultative Procedure under Section 83 of the Local Government Act 2002, allowing for a submission period on the proposed bylaw.

3 CURRENT SITUATION

- 3.1 The Statement of Proposal was advertised in the Hokitika Guardian and on the Council's website, and in the Westland Matters newsletter. The consultation period ran from Monday 15 October through Friday 16 November 2018.
- 3.2 Sixty four submissions were received which related to the Statement of Proposal.
- 3.3 Eleven submitters wished to be heard.
- 3.4 After a scheduled hearing on 29 November 2018 of submitters who wish to be heard and made themselves available, the Council will formally receive all submissions, deliberate, and give instructions to staff to prepare final versions of the bylaw in line with their decisions on each submission.

4 OPTIONS

- 4.1 The Council has already deliberated and make decisions on the submissions, at its meeting of 29 November 2018. The options now are around whether to adopt the bylaw subject to amendments being made accordingly.
- 4.2 Today's options are essentially as follows:
 - Option One: Adopt the bylaw subject to the Council direction that staff are to amend the Bylaw according to decisions made through consideration of submissions.
 - Option Two: Adopt the bylaw as drafted with no amendments.
 - Option Three: Do not adopt the bylaw.

5 SIGNIFICANCE AND ENGAGEMENT

- 5.1 Under the guidance of the Council's Significance and Engagement Policy, the decision to be made today is considered to be of medium significance. It deals with a number of regulatory issues throughout the District, most of which potentially have an impact on many of the District's residents and businesses. In some cases, the changes proposed are minor, and in other cases they are more substantial.
- 5.2 District-wide consultation has occurred through the Special Consultative Procedure under Section 83 of the Local Government Act. The submission period ran from 15 October through 16 November 2018.
- 5.3 The Statement of Proposal inviting submissions was advertised in the Hokitika Guardian, in the Westland Matters electronic newsletter, on the Council website, and through circulation to business and community groups and associations.
- 5.4 Submission forms, and the proposed bylaw, were made available on the Council website and at Council offices.
- 5.5 Sixty four submissions were received, and any submitter who wished to be heard had an opportunity to be heard at the hearing held 29 November 2018 prior to the extraordinary Council meeting held to consider the adoption of the bylaw.
- 5.6 After the decision to approve, there is a legislative requirement to place a public notice in a local newspaper advising of the Council's decision to adopt the bylaw, and to make this document available at Council's office and on its website.

6 ASSESSMENT OF OPTIONS (INCLUDING FINANCIAL IMPLICATIONS)

General options

- 6.1 The general options above have been assessed as follows:
 - Option One: Adopt the bylaw subject to the Council direction that staff are to amend the Bylaw according to decisions made through consideration of submissions.
 - Option Two: Adopt the bylaw as drafted with no amendments.
 - Option Three: Do not adopt the bylaw

Financial Implications

- 6.2 The direct costs to Council of having a bylaw are likely to be minor. The initial costs of staff to undertake compliance and enforcement will be aided by Government Tourism Infrastructure Funding. It is likely that eventually these positions will become self-funding through infringements associated with the compliance and enforcement.
- 6.3 In addition, the financial costs to the Council and the community of having inadequate bylaw controls would likely outweigh the direct costs of having appropriate bylaws, as negative outcomes could include more human waste and rubbish in inappropriate locations.

7 PREFERRED OPTION AND REASONS

- 7.1 The preferred option is Option One, adopting the bylaw subject to the Council direction that staff are to amend the Bylaw according to decisions made through consideration of submissions.
- 7.2 This option is recommended because it allows the bylaw to reflect legislation, to reflect best practice in local government where appropriate, to incorporate amendments for clarity. It also incorporates further amendments based on Council's consideration of submissions received in response to the Statement of Proposal.

8 RECOMMENDATIONS

- A) THAT Council receive and consider the submissions
- B) <u>THAT</u> after deliberations Council instruct staff to amend the Freedom Camping Bylaw as determined.
- C) <u>THAT</u> the amended Freedom Camping Bylaw be adopted.
- D) <u>THAT</u> the decision of Council be made publicly available.

WESTLAND DISTRICT FREEDOM CAMPING BYLAW 2018

1. EXPLANATORY NOTE

The Westland District Council makes this Bylaw under section 11 of the Freedom Camping Act 2011. This Bylaw should therefore be read alongside the Freedom Camping Act.

This Bylaw should also be read in conjunction with the Westland District Council's Freedom Camping Policy.

2. TITLE

This Bylaw is the Westland District Council Freedom Camping Bylaw 2018.

3. PROCEDURE AND COMMENCEMENT

The initial resolution adopting a statement of proposal for this Bylaw was passed by the Westland District Council at an extraordinary meeting of the Council held on [date] and, following consideration of submissions received during the special consultative procedure, this Bylaw was made by a resolution at a subsequent meeting of the Council on [date].

The Bylaw comes into force on the day after its final approval [date].

4. <u>DEFINITIONS</u>

In this Bylaw, unless the context requires otherwise:

Act means the Freedom Camping Act 2011.

Camping ground has the meaning given in section 5(3) of the Act.

Council means Westland District Council.

District means the district of the Council.

Freedom camp has the meaning in section 5(1) and (2) of the Act.

Local authority area has the meaning in section 6 of the Act.

Prohibited area means an area identified in Schedule 1: Prohibited Areas for Freedom Camping in which freedom camping is prohibited.

Restricted area means an area identified in Schedule 2: Restricted Areas for Freedom Camping in which freedom camping is permitted subject to restrictions.

5. PURPOSE

The purpose of this Bylaw is to control freedom camping in the Westland District in order to:

- (a) protect local authority areas;
- (b) protect the health and safety of people who may visit local authority areas; or
- (c) protect access to local authority areas.

6. LOCAL AUTHORITY AREAS WHERE FREEDOM CAMPING PERMITTED

Freedom camping is permitted in any local authority area within the Westland District unless it is restricted or prohibited in an area:

- (a) in accordance with this Bylaw; or
- (b) under any other enactment.

7. PROHIBITED AREAS AS OUTLINED IN SCHEDULE 1

- (1) A person must not freedom camp in any prohibited area identified in Schedule 1: Prohibited Areas for Freedom Camping.
- (2) Despite subclause (1), a person may freedom camp in any prohibited area if he or she has obtained the prior written consent of the Council, granted under clause 9(1), and complies with any conditions on the consent.

8. RESTRICTED AREAS AS OUTLINED IN SCHEDULE 2

- (1) A person may freedom camp in any restricted area identified in Schedule 2: Restricted Areas for Freedom Camping, but must comply with the restrictions listed below and any additional restrictions listed for that area in Schedule 2:
 - (a) Freedom camping is limited to "Certified Self-Contained Vehicles" in accordance with NZS 5465:2001; and
 - (b) Freedom camping at any one location or within 500m of the same location is limited to no more than two consecutive nights, and no more than 10 nights per 30-day period.
- (2) Despite subclause (1), a person may freedom camp in any restricted area if he or she has obtained the prior written consent of the Council, granted under clause 9(1), and complies with any conditions on the consent.

9. PRIOR CONSENT FROM COUNCIL

- (1) The Council may grant consent to a person to freedom camp in a prohibited area or a restricted area, with or without conditions.
- (2) Consent must be applied for in writing to the Chief Executive Officer of the Council at least two weeks in advance of the date planned for freedom camping in the prohibited area or restricted area.

10. OFFENCES

- (1) As specified by section 20(1) of the Act, every person commits an offence who
 - (a) freedom camps in a local authority area in breach of any prohibition or restriction in this Bylaw that applies to the area; or
 - (b) makes preparations to freedom camp in a local authority area in breach of any prohibition or restriction in this Bylaw that applies to the area.
- (2) Any person who has obtained the prior written consent of the Council, granted under clause 9(1), and who complies with any conditions on the consent, is not acting in breach of any prohibition or restriction in this Bylaw.

11. PENALTIES

As specified by section 23(1) of the Act, every person who commits an offence pursuant to section 20(1)(a) and (c) of the Act is liable to a fee of \$200.

12. <u>RELATIONSHIP OF BYLAW WITH THE NGAI TAHU CLAIMS SETTLEMENT ACT 1998</u>

This Bylaw does not limit or affect the rights in relation to nohoanga entitlements under the Ngai Tahu Claims Settlement Act 1998.











Proposed Prohibited Areas for Freedom Camping Westland District

Gibson Quay west of Beach St, Hokitika Reason: Access (high demand for locals and visitors)








Proposed Prohibited Area No. 14



Reason: Access and safety (narrow road, part of West Coast Wildemess Trail)











Proposed Prohibited Area No. 24




























Proposed Prohibited Areas for Freedom Camping Westland District

Submission: I oppose the proposal

Type submission here: Opening Remarks:

We all know what we want from Freedom Camping. The trouble is that what we want is not necessarily available to us in law. Right now this will not be fixed by by-laws. The problems of freedom camping go much deeper, as many confusing and contradictory Acts of Parliament impinge somewhere or other on freedom camping (see Annex A). All need to be met. Much still needs to be done before a secure by-law can be introduced.

Up until 2011 Councils said where freedom camping was allowed and under what circumstances. This arrangement was turned upside down by a realisation dawned, while preparing a set of updating regulations, that it was not consistent with New Zealand Human Rights legislation. This allows that no-one can be denied access to, or ejected from, a public space that they have a right to be on. The intended quick fix of the old old regulations was replaced by a new Act of Parliament specifically covering freedom camping.

Under this Act Councils can no longer say where freedom camping can not be done, only where it can't. The Act recognises that people are entitled to access, and to use, specific bits of land controlled by a local authority for the purpose of camping. If health and safety problems exist on any bit of that space then Councils may prohibit camping on it, or allow camping subject to conditions. Camping may also be prohibited by other legislation but Council camping by-laws must be consistent with New Zealand human rights legislation.

This creates a minefield for Councils, as any by-law that seeks to deny some people access to a public space, while allowing others to use it, cannot escape being inconsistent with the human rights legislation. This is the issue that tripped up the 2013 by-law, when the NZMCA pointed out that parts of it were inconsistent New Zealand human rights legislation. The barrier that ankle tapped the 2013 by-law remains. This submission looks at how it affects the 2018 proposal.

The proposal is essentially a redraft of the 2013 one, incorporating what the NZMCA sought at that time, but still containing the other in-consistencies of the earlier document. As it stands a challenge to it can be expected. As a ratepayer I see no good news in that possibility. Best to get it right now.

The Reserves Act prohibits any temporary or permanent accommodation on Council Reserves so Freedom camping is already widely prohibited on many bits of Council controlled land, and no extra by-laws are needed to to control camping on reserves.

Access Roads:

The proposal describes the physical condition of the access roads leading to its proposed banned freedom camping sites. I find this strange. A banned camping area my be identified by reference to the formed road passing through it, but banning freedom camping on the road itself makes no sense. With luck the road identifications refer to the entire road reserve, and not just the formed road itself. No by-law is necessary on a road reserve as the Reserves Act provisions apply here as well.

What is left is any bits of Council controlled land within 200 metres of the road. On these sites a prohibitory by-law may be necessary, but not because of the narrowness, steepness or bumpiness of a road. A road is a road and there are many reasons for using it, most of them disconnected from freedom camping. If the narrow, steep and bumpy road is a health and safety hazard then it should be closed to all traffic, not just freedom campers. I would read "access" in the Act as meaning the much smaller track that leads from the formed road into the site itself. It is the dangers or vulnerabilities presented by the sites, and these access tracks, that need to be taken into account when deciding whether or not the site is suitable for freedom camping. The condition of the formed road to it is irrelevant to ranking the site.

The The Concessionary Proposal:

A local authority cannot set aside sites for freedom camping. The Freedom Camping Act has already done that by establishing freedom camping as an activity available as of right on specified local authority controlled land.

Any given site is either suitable for freedom camping, suitable with conditions attached, or unsuitable under any circumstances.

The Council cannot pick and chose who does or does not get to camp on a given site. There is no power in the Act that grants a discretionary power to allow some campers access to a site, while denying it to others. If the Council determines that camping must be prohibited on a given site then no-one may camp on it under any circumstances.

The health, safety, and potential damage vulnerabilities that led to the ban do not disappear when some-one writes to the Council. If the vulnerabilities have been addressed then the Council must remove that site from their banned sites list. If they have been ameliorated to the extent that camping can be allowed subject to conditions then camping under those conditions must be made available to all. No application to camp is necessary.

Self Containment:

A New Zealand Standard for self containment of wastes in caravans and motor caravans has been in place since 1990. It predates the Freedom Camping Act and was used as a condition of camping under the old regime. Its purpose statement clarifies that compliance with it is not compulsory, but that it might provide access to camping sites that would otherwise be denied. This was true up to 2011, but Parliament declined to endorse a special status for it when considering the Freedom Camping Act. The official advice on this matter was "Vehicles are only as environmentally friendly as the people who inhabit them".

The standard was born into a different world from the one laid out in the Act. When set against the Act it is lacking in scope and outmoded in its technical details. What was inconvenient under the old

arrangements is discriminatory under the Act. The Act must determine what should be in the standard, not the other way round. The standard needs to be up-dated and brought into line with current motor vehicle registration law, as well as the Freedom Camping Act, before it can be used as a secure basis for a by-law. (see Annex B)

The officials declared in 2011 that self containment was a matter for the local authorities, Councils could decide the level of containment, if any, on any given site. This is disingenuous. The officials also advised that campers can only be ejected from a site for offenses against the Act, and that offending against a by-law is not the same as offending against the Act. No matter what level of self containment a Council decides on, its enforcement officers can only eject a camper from a camp site if they have been caught in the act of littering, depositing offensive material or damaging the site. A suspicion that they might do so is no cause for ejection. That has interesting implications for a fine against a by-law in limbo. If a camper cannot be ejected from a site, how can they be fined for remaining there?

.....

The 2 Day Stay:

Moving on every two days gives opportunity to empty camper waste holding tanks on a regular basis. The problem is that time stay bans cannot guarantee that that will happen. The only way to ensure empty tanks is to inspect for them when the vehicle first appears on each and every freedom camping site.

This is plainly impractical.

Any motor vehicle at all is a potential freedom camping shelter. Enforcement of an "x" day stay regime, whether that be by days on site or days per month, entails real time tracking of every vehicle passing through the WDC District and every freedom camping site on every day. Forget it!

Annex A: The Scaffolding For Freedom Camping.

The Freedom Camping Act 2011 is unusual in that it leans upon, and is affected by, many other Acts of Parliament. Those pertinent to this submission are listed below.

The Bill of Rights Act 1990. (Section 18 – Freedom of movement).

Everyone lawfully in New Zealand has the right of freedom of movement and residence in New Zealand.

The Human Rights Act 1993. (Section 134 Offenses – paraphrased) It is an offense to refuse access to, or use of, a place or space which members of the public are allowed to enter or use. It is also an offense to refuse access to facilities in such a place which are available to members of the public, or to require any person to leave or cease to use that place or facilities.

The Freedom Camping Act 2011 (Section 5 Interpretation) Freedom Camping is camping on land controlled by Local Authorities within 200

metres of a motor vehicle accessible area or a formed road in a tent, caravan, car, campervan, housetruck or other motor vehicle.

2011 Departmental Advice to the Select Committee considering the Freedom Camping Bill: There is no need to provide a definition of "camping" as it has a natural meaning of "staying for a short time in temporary structures in outdoor or remote locations".

The Land Transport Act 1998 (Section 1 Interpretation) "Road" is any place to which the public has access, whether of right or not.

The Reserves Act 1977 (Section 44 Unauthorised Use of Reserves) No person shall use a reserve (or any building, caravan, tent, or structure

situated therein) for the purpose of permanent or temporary personal accommodation.

Motor Vehicle Register Attributes. Table 2.2.1 Vehicle Type Codes and Definitions.

The Interpretation Act 1999 (Section 5 Ascertaining Meaning of Legislation)

.....

Annex B: An Analysis of the Self Containment Standard.

The standard is limited in a general sense as it was created as a voluntary document with the stated purpose of facilitating camping on sites that did not have sewage facilities. Whether viewed as a voluntary or a required document it has no power on a site with a toilet. The on-site toilet provides coverage for the Act's offense that no-one shall deposit obnoxious or dangerous material while freedom camping.

The only legitimate descriptions for motor vehicles in New Zealand law are those contained in the Motor Vehicle Register. The motor registration term for what the standard describes as "motor caravan" is "self propelled caravan." There are no "motor caravans" on the New Zealand vehicle register. The MCA may adopt any description it likes for its members vehicles, but the Freedom Camping Act must defer to the motor registration descriptions.

The standard is limited in the specific sense as it applies only to "caravans" and "motor caravans". The Act covers any motor vehicle at all, but the standard provides no authority to inspect, certify or reject those other vehicles. The distinction is important as the register sets a lower threshold for when a vehicle passes from being a "goods vehicle" to also being a "self propelled caravan" and therefore whether it does, or does not, fall within the ambit of the standard. (The registration definition for" self propelled caravan" is a goods vehicle permanently fitted with at least one sleeping berth and a table).

The Act applies to any motor vehicle from a moped onwards, right up to a large truck with a sleeping berth. All are recognised as shelters within which people may freedom camp, but most cannot be assessed against the self contained standard as, by definition, they are not covered by it. An insistence on obtaining a self contained certificate as a prerequisite for camping in these vehicles is akin to a Monty Python sketch where a suitor must first complete an impossible task before claiming their fair lady.

There are any number of ways that small cars or motorcycles, with a bit of assistance from a tent or a trailer, could satisfy the litter and deposit of obnoxious materials cautions of the Act to the level demanded by the current self containment standard, and yet still be denied access to a camping site for lack of certification. The standard needs to be be called in and modernised before it can serve as a pre-condition of camping.

Even then the value of a self containment certificate is questionable. A self containment certificate informs us on the state of the vehicle as presented for its certification inspection, but it tells nothing about its state when it trundles onto a camping site. A certified self contained vehicle with its containment tanks full is indistinguishable from a non self contained one. In

2011 the officials cautioned that this created a unique vulnerability – the risk of on site discharge of a large volume of human waste. The advice that "vehicles are only as environmentally friendly as the people who inhabit them" is true. A self containment certificate gives no guarantee that an offense against the Act will not occur.

Dear Westland District Council staff and Councillors

In response to the proposed Freedom camping bylaw, the Franz Josef Community Council would like to make the following comments:

- 1. The community strongly oppose the proposed council site at Docherty's creek which will create problems that do not currently exist. These have been discussed at length at the recent meeting which we are grateful for the CEO and council staff attending. At the most recent and all past community meetings, the vast majority of the community have strongly opposed the reopening of the site that was closed by council due to the huge number of vans parking at the site and the inability to effectively control the extensive negative effects.
- 2. Due to the far higher than normal volumes of both tourists and freedom campers who choose to stop and take photos or camp in the Glacier Country scenic roadside spots we believe in the interest of public health (people coming into contact with human faeces and general rubbish left by freedom
- campers) we believe freedom camping should be banned between Whataroa and Bruce Bay including Okarito and all other side roads. Due to the volume of people involved in scenic "hot spots" we believe this particular part of South Westland poses are greater risk to human health than other areas and so freedom camping should be completely banned. Note this area is also blessed with many private and DOC camp sites.

Specific examples include but are not limited to:

• Due to the narrow streets, the need for large buses to turn regularly and general heavy summer traffic volumes Freedom Camping should be banded between Oasis Motel and the Waiho River (including side streets such as Cron street)— an easily defined area encompassing central Franz Josef and the areas of greatest traffic volume.

- Due to the limited parking / turning space and high summer use by boat owners Freedom Camping should be banned at Jetty Bay, Southern end of Lake Mapourika.
- Due to the sensitive environmental nature and risks of human waste entering Lake Mapourika (used for swimming and water sports) if within Council power we wish to see Freedom camping along the entire length of Lake Mapourika.
- 3. We would like to see council efforts focused on enforcement and education, with regular patrols in the evening by council officers.
- 4. Several members of the local community have expressed a willingness to work for the council on a volunteer basis to help educate and enforce any bylaw if a percentage of the fine went back to the local community.
- 5. We would like some of these funds spent on rubbish bins and collection in town and from the sides of the state highway and scenic spots frequented by freedom campers

SUBMISSION ON THE PROPOSED FREEDOM CAMPING BYLAW 2018

Introduction

- The New Zealand Motor Caravan Association (NZMCA) appreciates the opportunity to submit on the Westland District Council's proposed Freedom Camping Bylaw 2018 (the bylaw). We wish to speak to this submission (preferably by videoconference if the facility is available).
- Over 85,000 individual New Zealanders are current financial members of the NZMCA and share
 a passion for exploring our country at leisure in their certified self-contained motorhomes and
 caravans. Most NZMCA members are hybrid campers frequently alternating between
 commercial campgrounds, DOC campsites, NZMCA Parks and freedom camping areas.
- 3. The majority of NZMCA members are retirees and baby-boomers who uphold the principles of Tikanga (respecting local etiquette) and Kaitiakitanga (protecting our environment) when visiting local places. The West Coast is a popular holiday destination for members and their families. They enjoy experiencing a variety of West Coast events, activities and attractions while camping overnight in towns like Hokitika (an official Motorhome Friendly Town).
- 4. Close to 1,000 individual members call the West Coast home and many enjoy freedom camping with their families in their own backyard. Therefore, the proposal will have a significant impact on the ability for thousands of New Zealanders and West Coast residents alike who enjoy freedom camping responsibly within the Westland District.
- The NZMCA is a strong advocate for responsible camping in certified self-contained motorhomes and caravans. We support local bylaws and policies that uphold the permissive premise of the Freedom Camping Act 2011 (the FCA) and, if deemed necessary, restrict freedom camping to certified self-contained vehicles only (as the bylaw proposes).

Summary and key recommendations

- The NZMCA <u>supports</u> the main thrust of the bylaw, including the proposed restrictions.
- The NZMCA <u>recommends</u>:
 - Clearly defining 'certified self-contained vehicle' taking guidance from the Model Freedom Camping Bylaw;
 - Amending Schedule 1 and designating restricted sites within prohibited areas for those travelling in certified self-contained vehicles; and
 - Amending Schedule 2 to ensure the restrictions apply only to local authority areas as
 required by the FCA (the current wording implies the bylaw also applies to land outside
 the council's jurisdiction).

General comments

- In preparing this submission we have read the statement of proposal and freedom camping report included in the Extraordinary Council Meeting agenda dated 11 October 2018 (the report).
- 9. We commend the council for proposing a bylaw in line with the FCA's bylaw-making requirements, while recognising the issues that may / may not be taken into consideration. For example, the council acknowledges in the report that it cannot restrict or prohibit freedom camping without justification and that perceived competition with existing accommodation providers is not a valid reason to limit the areas where freedom camping can take place.
- 10. We also agree with the report's recommendation that a blanket prohibition on freedom camping in parks and reserves is unnecessary, and that a site-by-site approach should be taken. Proportionality is a fundamental condition of any freedom camping bylaw. Other local authorities, e.g. Whangarei and Tauranga City Council's, have taken advantage of their delegated powers under the Reserves Act 1977 to permit freedom camping on reserves in order to achieve greater consistency with their freedom camping bylaws.
- We support the council's endeavor to achieve a consistent and permissive approach with the
 other West Coast districts. Maintaining a permissive approach towards (at least) certified selfcontained vehicles will help maintain Hokitika's Motorhome Friendly Town status.

Schedule 1 - Prohibited Areas

12. While we respect the council's ability to prohibit freedom camping in specified local authority areas, we believe there is scope to relax the rules by restricting certified self-contained vehicles to designated sites within some prohibited areas.

- 13. For example, freedom camping is prohibited throughout Beach Street, however we believe the council can afford to designate sites in amongst the prohibited area without compromising access for other recreational visitors to the area. This would strike a fairer balance between the range of visitors including responsible campers, who enjoy using the parking area. Other local authority bylaws have followed a similar approach. Other councils have also adopted a flexible and dynamic approach to managing these restricted areas, allowing them to increase or decrease the designated areas (by council resolution only) according to seasonal demand.
- 14. Over a year ago, NZMCA representatives met with the Council's Group Manager overseeing freedom camping to identify sites within Hokitika that would be suitable for freedom camping in certified self-contained vehicles (identified sites include those that are now prohibited in the bylaw). The purpose of this exercise was to demonstrate to the NZMCA that there are plenty of suitable overnight parking options for certified self-contained vehicles within Hokitika. This, in turn, enabled the NZMCA to grant Hokitika Motorhome Friendly Town status.
- We will elaborate on our suggestions to amending Schedule 1, including suitable areas where
 restricted camping could be considered, at the bylaw hearing.

We live at 8 South Spit Rd and also own 12 South Spit Rd and hold the DOC lease over the conservation land and reserve paddocks on South Spit. The house at 12 South Spit is tenanted and the paddocks are subleased to Marty Von Ah.

We have used South Spit recreating and/or living there for 40 years since first settling in the Hokitika area. So we know the area and its users well.

Our Attitude to the proposal

We congratulate Council on the overall proposed bylaw as we think it achieves a reasonable balance, given the constraints of the Freedom Camping Act 2011.

We generally support the Council's proposed bylaw, especially for its provisions for the areas in and around Hokitika which we know best. We think the bylaw will enhance local peoples' and discerning visitors' enjoyment of the area. But there are some amendments we would like to see.

Our proposed amendments are specifically for the proposed South Spit prohibited area, but some of these also have more general application to other prohibited areas.

Proposed amendments

1. Wording of Schedule 1: Prohibited Areas for Freedom Camping For South Spit Rd the current reasons are given as "Access and safety (narrow,

uneven road)"

We would like to see this wording amended to:

"Protection (penguin habitat), access, safety (narrow road and prone to coastal inundation)" Reasons:

South Spit and the adjacent beach is an important public recreation area. It is used especially by South Side and Hokitika area residents but also by visitors who are interested in the same activities as the locals.

This is a high use area, including for the following activities:

Walking, running, dog exercising, horse riding, sea and river fishing, firewood gathering, picnicking and barbequing, bird watching, watching sunsets, sunrises, moon rises and aurora, swimming, surfing and bodyboarding, bike riding, quad biking, motorbiking, canoeing and more.

All these uses depend on the access to the beach using the maintained portion of South Spit Rd between Mahinapua Creek and the car park at the beach. Many people leave their cars at the car park and go by foot or other means north on the Spit, often as far as the Mahinapua estuary and and Hokitika River.

From the Mahinapua Ck bridge to the beach South Spit road is a narrow gravel road and north up the beach from the car park it is just a sand-surface four-wheel drive track where two wheel drive vehicles and vans get struck on a regular basis. The car park is very narrow but access through it is required for vehicles moving further north up the rough track portion of South Spit Rd where it runs behind the narrow dune, or now on the beach itself in some places.

For the last few years the South Spit coastline has been subject to increasing serious coastal erosion. This threatens the car park and adjacent house, the rough driving track up the Spit, and the farm adjacent paddocks. At the carpark Council have put a bund to protect the park and adjacent land from flooding. This has restricted the width available for parking and the situation could continue to worsen. (In the WCRC Coast Plan South Spit is a Coastal Hazard Zone with removal of sand and gravel prohibited).

The car park and track north up the Spit is all subject to coastal inundation. Some of the track is now inundated on each big tide/big wave/lpw pressure system.

Most users use the area between dawn and dusk, but some also use it during darkness for uses like sea, trout and flounder fishing or family barbeques.

Several years ago, as campervans started to increase on the West Coast, vans started staying overnight at the South Spit car park and further north behind the dunes. With even 3 or 4 vans in the car park, access for locals' cars was blocked and often access to the track north was blocked. At times even 10 or so vans would attempt to use the area, and spill over back towards the bridge.

There are no toilet or other facilities on South Spit. Interestingly we have noticed over the years that some self-contained van people still defecate outside on the beach and in our paddocks if they can get away with it.

As problems started to increase Council provided us with a "No Camping - by order of WDC" sign which we have maintained. We have informally talked to people trying to freedom camp in the area, pointing out nearby alternatives like the DOC Mahinapua Campground and Links-View Holiday Park. 95% of the time people are happy to move on.

Little blue penguins nest along South Spit and use the car park to access their nests in scrub behind the road and on our properties. They survive because most people have either not arrived or have left when they move up and down the beach. Despite this we have found penguins killed by both dogs and vehicles over the years. Overnight stopping by freedom campers would make it very hard for the remaining population to survive.

2. Clarification of prohibited area of South Spit Rd

There is an ambiguity between the Schedule 1 Description "South Spit Road and the photo maps provided by Council with the bylaw.

The line on the photograph looks like just the formed road or track on South Spit, not the adjacent legal road where people actually stop and freedom camp. Also at the north end the

prohibited area does not extend for the whole legal road line, potentially allowing freedom campers to argue they are stopping outside the prohibited area.

This could be solved by: changing the wording in the location column from "South Spit Rd" to "All legal road on South Spit" The map could be better drawn too. This should be extended to the legal road immediately south of the car park where there have been people trying to claim they can freedom camp in the paddock beside the beach. And north of where the line stops - to the end of the South Spit legal road.

3. Providing for future changes in prohibited areas

We have noticed increasing numbers of freedom campers stopping on the road side along Golf Links Rd. This area is not currently proposed as a prohibited area. It is likely when the bylaw is passed and policed that areas like Golf Links Rd will suffer from a spillover effect with increased camping.

So, it would be good to see the bylaw providing for additions to prohibited areas by Council passing a resolution and by public advertising.

4. Wording of signs for prohibited areas

Having observed the relative effectiveness of various signs over the years the one that has been most effective has been those that were used by Buller District Council. These read simply:

"No Overnight Stopping"

We submit Council should try signs with this wording. If "fine print" has to be added to reference the bylaw etd then this could be done in smaller type, for the sake of completeness and avoiding ambiguity.

5. Compliance

We have found most people freedom camping on South Spit say either they did not see the (very obvious) sign or claimed it looked like it applied to tent camping and not van camping. But when spoken to as mentioned above, 95% move on without hassle.

We would be happy to assist Council with compliance with the new bylaw in the South Spit area.



While I commend Westland District Council for following legal due process in regards to this proposal, I can not support it .

On reading the supplied documentation, it appears that council is paying lip service to concerned business owners, affected land owners and the public in general. In the past council has shown an ineffectiveness in both enforcement and following up on any infringements that have occurred. I doubt that if this proposal is adopted, that there will be improvements.

The proposed 'exclusion areas" within townships are too complicated for both residents and visitors alike. For example, the eight itemised exclusion zones within the Hokitika township could all be itemised as 'any area west of Revell Street from Richards Drive to Gibson Quay inclusive. This removes any grey areas for interpretation.

The concept of "Certified Self Contained Vehicle" can not be assumed just because a vehicle has a sticker attached. Many vehicles have fake stickers, or only contain a portaloo. Most have no greywater containment or allow the greywater to flow through open drain valves. Many owners or hirers do not wish to deal with the contents and cleaning of the contained systems and I have caught many urinating and defacating next to their vehicle with an attached sticker. Some of the worst offenders are those sporting 'silver and red wing stickers' These people are free to do so because Hokitika has adopted a motorhome friendly status, which seems to give these people the opinion that they can do as they please.

The number of people who use the land that I have been obliged by council to maintain at my cost, as a 'public toilet', has increased. As the beachfront toilets are locked earlier than advertised, people are left with nowhere to go.

The 24 hour toilet has no advertising, so people can only locate it by chance.

On many occasions, including once last month I have been woken by one or more uninvited freedom campers in my house, looking for the toilet. If I happen to have locked my door I find excrement in my back yard along with toilet paper.

Encouraging freedom camping has major impacts on peoples safety and security.

Council has encouraged these people and the subsequent environmental hazards including increased refuse.

On enquiring about the reasonings for no bins, I was advised council had removed them due to excessive use. I asked the mayor if it was beneath him to pick up rubbish from the beachfront and sunset point, his response was "you live there, you pick it up". Not counting the recyclables, I have filled 29

200 litre black bin liners. Oh yes, I have to pay to dispose of it, as council considers the refuse mine as I picked it up.

My recommendation is that council take account of all submissions and rewrite the policy and get further feedback before passing a bylaw which it has no intention enforcing.

I also suggest a freedom camping zone, which has appropriate sanitation and disposal infrastructure as in other districts Do you wish to be heard in support of your submission?: No

Creek be included as a prohibited area.

Under the proposed bylaw the majority of beach access roads from Hokitika to Serpentine will be prohibited for freedom camping and this has the potential to increase the numbers who use the Flowery Creek/Awatuna access. It is already common for people to camp in the area and dispose of their waste inappropriately. This access road runs through our dairy farm which means there are a number of health and safety issues. The road itself is uneven and covered in sand at the beach end. It is common for vehicles to drive out onto the beach itself and get stuck, as well as park over gateways used for stock and machinery. This road is used as a race for our animals and tourists are often unsure how to deal with stock. In mating season there is the danger of having bulls running with the cows. There are potential biosecurity risks in having our animals exposed to human waste, particularly with overseas tourists. We also have to deal with people leaving gates open and as our farm borders the state highway there is always a huge risk with animals getting onto the road.



- 1) I have questions and concerns around how this would be enforced in practise and at what cost to ratepayers.
- 2) I don't think vehicles should have to be certified as self-contained. All that is needed is some kind of system to deal with toilet waste and other waste eg a bucket with lid, that can be emptied at a dump station.

If Council was to stick with requiring that vehicles are certified as self-contained, I don't think this should be enforced if people are being responsible and dealing with their waste appropriately. I think the focus should be on responsible behaviour rather than whether a vehicle is certified as self-contained or not. Someone with a normal car and a small tent can freedom camp in a way that doesn't impact on others or the environment, while having a self-contained vehicle isn't a guarantee of responsible camping behaviour

SUBMISSION TO FREEDOM CAMPING BY-LAW

As a local Ross community group, WRENIS are requesting a Bylaw –'NO FREEDOM CAMPING' @ Grimmond Memorial Ave/All Ross Domain Reserve areas.

Concerns and Reasons below:

The Ross community has a vested interest in the Ross Domain Reserve and its surrounds. All maintenance of the areas is via local volunteers; this includes Fire Brigade practice track, Archery Range, Playing field and pavilion, plus the Chinese Memorial Gardens and Lakeside memorials, of which WRENIS have consent to do.

The Archery area is immediately adjacent to the East Carpark; increased activity by camping parties will create a dangerous mix.

The Chinese Gardens will be a Tourist attraction for the town, thru generous support by the Chinese community (\$180G), which is part of the overall Memorial Projects. This Tourist attraction is also supported and encouraged by Westland District Council, Ross Community Society and Department of Conservation, including our opportunities to further our planned/continued development and enhancements of the Reserve, Ave and Lakeside. With the gardens being in such close proximity of the East Carpark, this area in our view would be under increased pressure regarding the chances of criminal damage (as it is much easier to inflict damage after dark). (We have support letters from Chinese Sponsor groups, Westland District Council and Ross Community Society).

WRENIS have had support from Westland District Council staff, in assisting us in seeking funding opportunities to upgrade the East Carpark of Domain Reserve, to allow for safe off road parking for visitors for recreational fixtures, Chinese Gardens and other enhancements and developments – this includes safe access for Children's Fun Cycle area on the adjacent DOC Reserve. The safety of the younger population of Ross is hugely important, as it is for the older population who frequent the DOC reserve and recreation reserve.

Ross Community Society meeting minutes of 5th February 2018, in General Business, turned down anything to do with dealing with any motor parks: - Peter Bennett proposed the RCS become involved in a 'Charges Applied Property' on private land owned by John Dunbier at Gay Street. Eileen Jones and Charlie McBeath mentioned that they are not in favour of the RCS being responsible or associated with maintenance of the area, as it would place more burden on the already low number of volunteers as it would end up being the same people behind the scenes. Wayne Jones agreed, and the general consensus of that meeting agreed RCS to step back from such a proposal.

At a recent Ross Community Society meeting (2nd July 2018) there had already been discussion and a vote on the East Carpark area, regards any overnite/freedom camping.

The vote being: nays and some wanting more info = 7

on the fence = 2

against = 9/proxy against = 3

Ross Community Society meeting (6th August 2018), the Freedom camping Bylaw issues was up for discussion, with the meeting agreeing that all areas of Domain Reserve be void of freedom camping, due to FB practice track, Playing field and Archery – no support from the Chair for protection of the other areas, that the RCS are supposedly supportive of, ie Chinese Gardens, Lakeside enhancements, safe off road parking for recreational purposes, or the important safety for the adjacent Children's Fun Cycle area. WRENIS find this to be exclusive exclusion via the Chair's overriding influence and personal angst towards some members of WRENIS.

NZMCAssn have already secured a Private site (parking for roughly 20 vehicles?), for fully self-contained campers with their overnite fee going towards funds to the Ross Swimming Pool. This was brought about (Ross Swimming Pool) because the Ross Community Society Chair, Mr Charlie McBeath, at a meeting earlier in the year, as voted at the meeting (5th February 2018), that the Ross community society cannot afford to take on any camping projects, as future membership is low on numbers of interest as is the volunteers within the community as they are already overloaded.

Local residential recreational use of this area has increased hugely, especially with the community enhancement and development projects that are being undertaken. Community support for the local accommodation/motorcamp businesses is more important (as they employ locals) than having an area (that is being enhanced for recreational purposes) turned into a 'freedom campers bomb site', leaving their mess, that locals will have to continually maintain, which will end up becoming an increased rate burden (no doubt) in the near future, as volunteers are very short on the ground, and aside – who will patrol alcohol consumption in this public area. The alcohol content of Freedom campers, their habits and lack of responsibility are well documented in other areas of Westland – Alcohol, visitors and children do not mix well.

WRENIS have a contract with DOC to clear, develop and enhance the DOC Reserve (immediately adjacent to the East Carpark) and we can only foresee, that should any Freedom camping be allowed on the East Carpark area, that it will overflow into the DOC Reserve – this being a negative impact for all.

Carparking upgrade for visitors to Chinese Gardens has been endorsed by Chinese Community and Council Staff. (We have supported encouragement correspondence from Westland District Council and Chinese Groups to have the carpark upgraded for increased visitor numbers to Gardens, as well as the Domain recreational area for sport and other community events)

Small communities, should not be subject to Freedom camping; a prime example is nearby (south) Monument Hill/Surveyors Memorial – freedom campers 'wasteland' is a disgusting mess within a public scenic look out area. No one maintains this area – volunteers or authorities.

There has already been deliberate damage to some of the already enhanced areas at the local Domain, Lakeside and DOC reserve, by a local resident; inviting transient overnite stayers will only add to said behaviour.

Consideration to streets of Ross should also be taking on board: ie – Beach Road, Hoos Street, Bonar Street, Simpson Street, south end of Sale Street, Bold Street, Bond Street, Park Terrace, Gay Street, Limeworks Road, Cemetery, Woolhouse Road, Petticoat Lane, Frazer Street, Stewart Street, Tramway street, Hirter Street.

My Credentials

I have worked for the HDC, Seaview Hospital, Livestock improvement, as a life tutor for a Government department, the WDHS, on farms,

as a music tutor, as a musician, as a Jade Factory employee and Jade Factory Manager. The last 28 years I have been a self employed jade carver artist in the town of Ross.

I also started life in a big family and have a big appreciation of attitude dynamics as per responsibilities not only to oneself but to the wider community.

I was born in Hokitika and have resided on the Westcoast for over 66 years.

I have lived in Ross for around 45 years and have had a working job for around 54 years on the "Coast".

I have worked in or around tourism for 46 years.

The subject of "Freedom Camping"

Early on in my career in the tourist field working for other people out the back and away from the clients I held a view that freedom camping was the way to go.

When and after a small amount of time in a Jade business of my own dealing with prospective customers of all personalities and races and seeing the changes in

Freedom Camping (habits wise) I am almost sad to say I now have the opposite view.

In Ross we now have a local (seemingly) freedom camping area on a section at the entrance to the business district. I have no idea whether this is a legitimate site

employing locals or not. That said if it is not why are there not more private accommodation businesses set up?

As a very small business I can assure you I generally have only one person a year that purchases off me from the seemingly freedom section down the road

let alone all the freedom campers that pass by, yet these "freedom campers" are using public conveniences which I and other ratepayers are forced to pay up for

under "Rates". Freedom Campers here frequently arrive here late in the evening and depart at around 6 in the morning.

I am sure that were I to go to Christchurch and set up camp in the middle of Hagley park I would get a short shift.

People coming through the coast need to pay their way. We should all pay our way re motels Hotels camping grounds when we go to other Counties throughout NZ.

It comes down to this, only by travellers contributing financially to local body expenses can a true cost financing curve be introduced.

I have experienced the Ross Beach when buses have dumped their passengers load, I do not wish to experience the Ross recreational reserve and car parking areas to go this way.

If the WDC wish to have jobs available for the population of the coast the WDC need to be active in promoting no freedom camping.

The Mantra should in my mind be "Responsible Camping", camping where people in camping vehicles are expected to pay their way as regards Council facilities and set up.

Encourage privately run camping grounds!

With free camping comes the fringe problems, that of the food chain. Folk living here have secondary food source whether in the bush, down the river or in the sea.

This will not last long if freedom camping is encouraged this puts huge pressure on those local people who find it hard to make ends meet.

Introduce well heeled folk who have a motor home house and properties in another part of NZ, money to afford all the fishing gimmicks and

hey the fish are gone and so the space at the beach or river. Motor homes at this time are legally able to park overnight pretty much wherever they like no rates no parking fees,

Bludging..... no other way to put it.

- 1. By agreeing to retain the status quo we loose the potential to employ more of the coasts population.
- 2. By closing down Freedom camping we offer more employment to our population and even increase the stable population of the West Coast.
- 3. By closing down freedom camping we may meet the costs of supplying water, sewage and dumping.
- 4. Many high fliers in the Westcoast Business arena bemoan the loss of jobs remining. Now is the chance to do a bit of a U turn into something newer with more potential long term employment, will we do this?
- 5. You spoil the child, you will suffer and others will continue to suffer it will remain an endless circle.
- 6. I would encourage the WDC to take a firm stance on freedom Camping and say no. We need people coming through here to at least pay their way.

 As said before Encourage privately run camping grounds!
- 7. Of Ross my opinion is that freedom camping absolutely needs to be stopped over all areas of the Recreational reserve including the East car park opposite the Chinese Gardens. Close the beach and rivers to freedom camping what many coasters do not appreciate is that other area of the world have no beach's like ours. They have beach's covered with Humans, animals and rubbish.

Freedom Camping can ruin the attractions the West Coast already has to attract people here from overseas.

In a while we will have a children's BMX circuit created near the recreation ground Ross, there would be a conflict of interest having visitors carrying alcohol, using alcohol and parking overnight. We already have a thriving Archery Range in the vicinity.

- 8. Many years ago representing NZ at the world physically disabled cycling champs I saw the amount of volunteer work undertaken by local groups picking up thrown, discarded -rubbish of the roads. In order to give a visual effect that everything is good in the world this volunteer work is undertaken. This work which is undertaken by these well meaning volunteers takes these giants of society away from what they could have created otherwise in their community. You could say it is chasing your tail. If NZ embraces Freedom Camping this is in effect what will happen.
- 9. Many of my age group were not spoiled we knew the difference between taking up the load and not bludging but contributing.
- 10 I should say this that I and my wife give away fruit every year we give of our own will to locals and visitors. We pretty well give most things we possess away if in good nick. I wish you to understand my slant on this we give away only that which is ours. We are not impervious to the needs of others.
- By closing down freedom camping I believe we will bring self supporting visitors to the coast who will supply their needs through local businesses. We need people who will be interested in more than alcohol, fuel for a vehicle and supermarkets. Call me selective if you like, in life we all make choices It is from my experience that I firmly believe Freedom Campers leave less and take more.

We need visitors to be of a responsible type to contribute toward the costs we incur because they wish to enter and use this place in some form.

At this time my last four days has contained about 30 plus hours of local and non local volunteer work. I am sure those reading this script would be in the same place regarding volunteer work as I am.

There is well placed volunteer work and there is meaningless and backward volunteer work. Freedom Camping demands Volunteer work of the negative kind. The normal inhabitant of a town, city, pays rates and so everyone that comes through one who uses any of the local Councils utilities

should be prepared to contribute also.

There are comments around that we need to welcome people here by giving.... there is good giving and bad giving. Freedom camping is a problem, providing it encourages over use over indulgence and can leave a battered, tired and bruised community.

Volunteers here are thin on the ground the, Westcoast only has so many people willing to give day after day.

Any one knowledgeable enough on travelling overseas would come on the usual question "Do you have sufficient funds for your stay here"? These people are asked this question for a reason. The freedom campers from other parts of NZ also... do you think they are bothered when they hop across a fence in Ross to pluck a tree load of pears from a Ross residents tree or take the Blackberries at the section of another when these people in Ross grow these as a food to get them through the year?

It is rather ironic in a Conservation area which is under threat of being locked up on the New Zealanders, we are now being forced to accommodate the freeloading foreign campers who are allowed to come in and do what they want, when they want. • If they came here for one month and paid \$30 per night to stay in a campground, it would cost them LESS THAN \$1,000.

My point, whats another \$1,000 when they clearly have the money it takes to get here and travel around our country and do all the fun expensive activities?

For an extra \$1,000 from them, We get our clean roadsides and carparks back, local accommodation providers who have a 7 month window to make a living will be better off financially and the Govt (and then I'm guessing but hoping not.)

council/ratepayers/us) won't have to prop these 2 employees up and their enormous fuel and accommodation bill while they drive up and down the West Coast checking on freedom campers.

Central Government are employing 2 people to drive the length of our district every day for 7 months and monitor these freedom camping sites.

- Who pays them after that?
- What is the actual chance of two people (even IF they live at opposite ends of Westland District) monitoring the entire area 7 days a week?
- Will they collect AND dump rubbish at the local dump and will they clean the toilets and site each day?
- Will they pick up rubbish around the perimeter of the actual designated site each day and the rubbish which will blow onto the beach.
- after the 7 month period, WHO pays for the dumping of all rubbish left at freedom camping sites?
- In Haast it costs us \$4 per rubbish bag and up to \$150 per trailer to

dump and we only have access to the dump for 4 hours per week.

- What will happen when locals start to leave their rubbish at the freedom camping site?
- Will the freedom campers light fires each night on the beach without permits, attempt to burn their rubbish, bottles and cans, extinguish the fire properly before leaving? Will the monitors have any power over this?

We were told "They spend money in your community" I disagree.

Haast is a destination for kiwis who love the outdoors.

For tourists, it's a stop over between 2 major tourist destinations, the Glaciers and Queenstown. Always has been. The garage might sell a tank of gas, but they make no money on fuel sales. I doubt the local stores sell much more than heat and eat foods which can be quickly prepared on a 2 burner gas cooker. I doubt many go to the pub for a \$35 meal and a cold beer.

Do people who dine on noodles and share a coffee spend \$120 on a jetboat ride? No. They don't. Unless it's in Queenstown of course.

I fear it will ultimately COST US to provide for the freedom campers. With 13% of our region rateable land and a 7 month window to make a living for a year, I can't afford to prop up someones holiday while raising 2 children. And I don't want to.

Safety.

The Haast Pass provides many a layby or sideroad/park for freedom campers as does the rest of our coastline. The Pass in particular is an area when in extremely rough weather people should NOT be up there by the river or under the mountain. After Diana Falls blew out, we were all made very aware of how fractured the entire mountain side is and with the tragic loss of two lives in that storm, no-one wants it to happen again.

Our local policeman or road workers should NOT have to drive up there in dangerous conditions telling people to move into the town for their own safety.

A few years ago a tourist went to a spot an APP told him he could camp. He woke up in the middle of the night floating down the Karangarua river in his little jucy car. Luckily he survived to tell the tale.

NO CAMPING signs must be placed right through the Haast Pass as well as by all beach accesses and river accesses.

Sadly our beach accesses and roadside parks are now littered with toilet paper and rubbish. It's disgusting and we are permitting it.

I agree they need to be contained, but I feel between the DoC camp grounds and the commercial campgrounds and accommodation providers, there is ample room for them to pitch a tent or park their vehicle.

Last summer I asked alot of my customers who were clearly freedom campers, where they stayed and what vehicle and facilities they had etc. Alot of them were in a car or station wagon. They had a porta potty but didn't use it. When I asked why not, one young couple even laughed and said they didn't know how. Come on, even toddlers from all corners of the world know how to squat or sit on a potty. They DIDN'T WANT to use it because they DIDN'T WANT to clean it. Poor and lazy excuse.

This self contained vehicle business is a joke too, you can't slap a sticker of a toilet on a car and call it self contained. Oh wait, that IS what they are doing. It's not on.

 Are the 2 people monitoring going to have the power to do Anything at all about that?

At the meeting in Haast this was discussed and the possibility of fines etc.

Theres nothing in place to make them pay any fines. Nothing in place to make them to pay as they leave our country. That needs to change.

If we are forced to allow freedom camping, they should be forced to pay any fines as they leave our country. It's only fair. If you get a traffic infringement in another country, you pay it.

- We need to set a standard. Respect our country and we will respect you.
- The West Coast is a conservation area. Respect it.

I left the meeting in Haast along with everyone else reluctantly agreeing to

2 freedom camping sites in our area after we were told, it's happening whether you like it or not.

My understanding is, there will be 2 sites in Haast accommodating up to 15 vehicles per evening, they will be monitored daily for 7 months, they will be kept clean and tidy and all rubbish will be removed, if it all turns to custard, they will be shut down. Central Government will pay for the development of the Hannahs site and will employ 2 people to monitor Westland District for 7 months.

We need guarantees that:

- If it turns to custard the sites will be shut down.
- Ratepayers NEVER be responsible for any cost relating to freedom campers.
- If the sites are maintained beyond 7 months, Central Government continues to pay for all expenses relative to the freedom campers. That includes the employment of monitors, the purchase of their vehicles, all the fuel and accommodation costs for those employees, the dumping fees of all the freedom campers rubbish and all related costs of removing sewerage from the portaloos and emptying into the local pond.
- NO CAMPING signage be erected right through the Haast Pass and all beach and river accesses in our district.
- The monitors are given the authority to remove campers in non designated sites and impose fines if necessary.
- WDC demands Central Government puts in place, a fine system collectable
 on leaving NZ for the people who disrespect our countryside and National Parks and that money to come back to the district the fine applies to.
- A car, station wagon or van with a toilet sticker slapped on a window IS
 NOT a self contained vehicle fit for freedom camping and if found camping outside a designated freedom camping area, they will be fined and the fine be paid on leaving the country if not before.
- Appropriate/relevant information is given to tourists on the plane trip over here and at ALL vehicle rental companies.

As a resident of Kumara, I am concerned that there are no prohibited freedom camping areas in Kumara in the proposed bylaw. I am concerned that freedom

campers will see Kumara as an ideal place to freedom camp (if they look online and follow the bylaw), and that some of our special local areas will be damaged or overrun by visitors to the point that locals are not able to enjoy our local areas, which we pay rates for, and will feel hostile toward tourists. During the tourist season of 2016-2017 the Kapitia Reservoir was overrun by freedom campers to the point where locals were not able to enjoy the area or launch boats without having to ask people to move their cars, litter and rubbish were regularly left at the site and people defecated in the nearby native bush, leaving exposed faeces, menstrual products and toilet

paper. I spent time with other residents and the Community Development

Officer cleaning up this waste on more than one occasion. Unfortunately, the situation continued even after a porta-loo was installed. With permission from Trustpower, my husband and I created, paid for and erected a sign encouraging people to please use the provided toilet, rather than "pooing"

and "weeing" in the bush. Last year the issues and misuse were mostly resolved after funding for a permanent toilet block, Trustpower prohibiting overnighters and the location was removed from tourist websites. Now the area is enjoyed by locals and visitors alike on a daily basis.

I share this story because I am concerned that with freedom camping banned in areas of Hokitika, Otira and Serpentine Beach, Kumara has the potential to become a freedom camping hot spot.

I would specifically like to see the Taramakau River at the William Stewart Bridge (access and safety-unmaintained road, environmental protection- river flow into the ocean = rubbish into the ocean), the Kumara Cemetery (protection- historically/culturally sensitive area), the Kumara Sportsground

(access- high demand by visitors and locals) and the tramline from Greenstone Road to the cycle trail (part of the cycle trail) (access and safety- high

demand for locals and visitors) as prohibited areas. I do support the

Sportsground allowing organised group camping through the Kumara Sportsground Committee. This means the community group could benefit from the funds and continue maintenance and upkeep at a high level.

While my proposal does considerably reduce the options for freedom campers in Kumara, there are still spots available and with freedom camping at the Kumara Junction Cafe and a camping business in Kumara township. I do not think the restrictions would hinder visitor experiences to our part of New Zealand. If anything, their experience would be enhanced as locals and businesses value their desire to experience New Zealand, without feeling taken advantage of or "shat" upon. My partner and I own the Shining Star Beachfront Accommodation, at 16 Richards Drive. Our facility includes 16 powered sites for campervans, as well as 5 unpowered sites.

The area that concerns us is referenced in the Statement of Proposal - Freedom Camping Bylaw 2018 as "End of Richards Drive, West of Revell St".

We would like to ensure that this remains a prohibited area for freedom camping. Firstly, there are no nearby facilities (toilets and/or showers) for freedom campers to use. Because of this, we have a regular and frequently-unpleasant job approaching and discouraging campers from using our facilities by sneaking in and blending with our paid guests. This situation will undoubtedly increase in intensity if freedom camping is allowed to take place immediately outside our business. The experience is a negative for the tourists involved and a negative for us as well.

Secondly, there is no shortage of paid sites for our welcome tourists to use.

Between our neighboring holiday park (252 Beachside) and ourselves, there is plenty of availability for the traffic that comes through.

Thirdly, using this area for freedom camping would devalue our business. This is not just because of the fact that we would compete against a free service, but also because this site would be located directly between our motel units and the beach. This would greatly diminish the aesthetic of our guests' views, which they pay a premium for.

We think that the establishment of freedom camping at the parking lot at the end of Richards Drive would be an overall detriment to the area. We don't think there is a need for it, and there are substantial drawbacks to the using this area in such a manner.
