<u>DECISION OF THE WESTLAND DISTRICT LICENSING COMMITTEE ON AN UNCONTESTED</u> APPLICATION

Authority:

Pursuant to section 191(2) of the Sale and Supply of Alcohol Act 2012 and a Council resolution dated 28 November 2013, the functions, powers and duties of the Westland District Licensing Committee are delegated to the committee chairperson where no objection has been filed, and no matters of opposition have been raised by the Police, the Medical Officer of Health or an Inspector. There is no Local Alcohol Policy in place for the District.

Summary of Evidence

A special licence is sought for the purposes of providing an alcohol service at The Fox Glacier Community Center on Thursday 7 March 2019 between the hours of 6.30PM and 12.30AM the next day.

A report from the Inspector concludes that the applicant is suitable to hold a special licence.

The Police have no objection to the application.

The Medical officer of Health does not oppose the application.

I note that the event is to be managed by Erica Ellen McLintock who is the holder of a manager's certificates and has considerable management experience within the hopitality industry.

Evaluation of Evidence

I have considered the application on the basis of the uncontested reports received and the complete file which has been made available to me. The application was not publicly notified. The matter can, therefore, be dealt with on the papers.

The event is a fund-raising event to support the work of the Fox Glacier Community Development Society.

The venue is the Fox Glacier Community Centre and sale and supply of alcohol is restricted to the kitchen and Social room. No designations are required.

The application is thorough and covers all the matters that go towards the safe and responsible sale and supply of alcohol.

Decision and Reasons

I am satisfied as to those matters provided for in s.142 of the Act.

The application is granted on the papers pursuant to s.202 (1) of the Act as Decision Number **030-2019** and I direct that a licence be issued pursuant to s.64 of the Act.

Pursuant to s. 213(1) of the Sale and Supply of Alcohol Act 2012, Erica Ellen McLintock is appointed to be the manager for the occasion of the event to which the application refers.

The terms and conditions will be:

The sale and supply of alcohol is restricted to the kitchen and Social room only.

The Licence may be exercised for the sale and supply of alcohol to any person lawfully attending the premises on Thursday 7 March 2019 between the hours of 6.30PM and 12.30AM the next day.

Pursuant to section 147(3)(b) of the Act drinking water shall be freely available from the bar and on the tables in the social room to all customers at all times that the licence is being exercised.
